Thanks to a stable secretariat, a strong determined and board and committed members, we have been able to meet challenges the those strategic directions, including major successes such the as Comenius Individual Pupil Mobility pilot

project, the International Educational Conference "Moving beyond Mobility" in Berlin, the European-wide Day of Intercultural Dialogue, the Volunteer Summer Summit in France. successful Worldoscope project, the production of the DVD Cultures Interact", the launching of European Citizenship new Trimester Programme, the openings Slovenia, Croatia. Bosnia/Herzegovina, Serbia and Poland, and a wide range of highly appreciated trainings ands seminars, not to forget the substantial amount of money raised through successful funding applications for trainings and projects. We gained a lot of visibility and credibility from the European institutions, ultimate evidence which the presence οf was Commissioner Figel' Jan at opening of our conference in Berlin last October.

Over the past decades, EFIL has played a role beyond expectations in fighting a battle to keep the topic of intercultural exchanges afloat and to influence the decisions that were taken by the European institutions over the years. Today, internal and external circumstances advise us all to take a fresh new look at our Federation. New challenges lie ahead of us. Europe has changed. Over the years AFS too has changed. EFIL cannot remain the same.

Looking at the political situation in Europe, with the treaty of Maastricht,

the Bologna process and the Lisbon Agenda, education now appears in the budget of the Union with large investments for educational exchanges, as a result of which more more individuals, students. teachers, schools and universities meet and work together through different cultures and nations. Mobility for mobility's sake will not be enough. The pedagogical aims and content of exchanges will receive more attention.

We have to concentrate more on thinking focusing outwardly and European and internationally. Our national organisations need to adapt their strategies and agendas to the constraints and possibilities offered by our European environment, and participate in the political process under way in Europe in each of our countries in the field of educational exchanges and citizenship building. We must address the growing interest for educational exchanges in Europe with cohesive and harmonious strategies, and we need to invest in effective cooperation among EFIL members in volunteer development, in staff stability in our national offices, in the enlargement of EFIL, in intra-European programmes elements of citizenship education, in high quality performance, and in visibility as an established and reliable player on the European educational scene.



SHAPING THE FUTURE — TRAINING ON ORGANISATIONAL DEVELOPMENT

In April participants from 14 European countries gathered in beautiful and remote venue in the mountains surrounding Croatia's capital Zagreb, for the EFIL training "Youth **Participation** through

Organisational Development".

EFIL's activities in new Partner development over the past two years

have concentrated on four Balkan Bosnia-Herzegovina, countries Croatia, Serbia and Slovenia, as well as Poland. Registered non-profit organisations are in place in each of these countries and have started exchanges with AFS organisations. The concept of the training in Zagreb was to support the organisational development young of these organisations, well as strengthen the growth of existing AFS organisations which currently struggle with organisational challenges.

In order to reach these ambitious goals the preparatory team consisting of Diana Rosta, Michela Bortoli, Hannes Wacker, Johannes Schirrmeister, Benjamin Ledwon and Izabela Jurczik, had compiled an agenda that struck a balance between content input sessions and actual work on the organisational development plan.

In some years, when the partners involved in the training will have succeeded in setting up sustainable AFS organisations in their respective

countries, we will look back at the Zagreb training as a major step in the process towards the development of those organisations.

EUROPEAN CITIZENSHIP TRIMESTER PROGRAMME MODULES FOR ORIENTATION CAMPS



After a short survey among the partners involved in the new ECTP programme, EFIL put together a short manual for sending and hosting orientation in the new programme,

taking off in the autumn of this year.

The manual contains background information, a list of activities and "Eurogizers", and some information on the End-of-Stay Camp in Brussels in November. For both Sending and Hosting, sides, provides a worked out module of about 1.5h with fully developed activities adapted from "Promoting Citizenship in Europe – a Training Manual (EFIL/AFS 2006)" and compass (http://www.eycb.coe.int/compass/). The list of about 30 additional activities also refers to T-Kit No 7 (Council of Europe and European Commission 2003) and an earlier compilation from EFIL created in with AFS cooperation Germany ("European Citizenship Awareness building in AFS: Training Material and background documents of interest"), other background as well as documents.

We hope this manual will be helpful for all partners involved in the new Trimester Programme!

EFIL is currently preparing a funding application with the Anna Lindh Foundation.

APPLICATIONS SUBMITTED

We are pleased to announce that EFIL submitted two new funding applications for training activities:

- "Intercultural Learning and Exchanges – where do we stand and what is the way ahead?"

This seminar aims at getting a better overview on the latest developments in the ICL field in Europe and on the position and role of AFS. Through the presence of external speakers and of key volunteers and staff from the AFS world, the seminar will explore our own educational frameworks and the possible synergies with external players.

the European Citizenship Trimester Programme. The Study Session is planned to be fully managed by volunteers: a volunteer Course Director, Anne Hitzegrad from AFS GER, contributed to the application writing and will take the lead in the project.

For both applications the results are expected in the second half of June, so stay tuned for further news!

"TRAINERS, JOIN US IN CENTRAL EUROPE"

An international training for trainers called "Trainers' JUICE – Trainers, Join Us in Central Europe!" will take place between 6th and 10th May near Brno in the Czech Republic.

The training is organised by AFS volunteers from Austria, Czech Republic, and Hungary and it is the activity of a long-term cooperation between the Pools of Trainers of these countries. The idea Central European **PoTs** cooperation emerged gradually during "Stop EFIL seminars underEASTimation" in Nectiny, Czech Republic, and "Pools of Trainers and Ideas" in Dworp, Belgium. The first planning meeting took place in January 2009 in Vienna and it was also a starting point of the Trainers' JUICE project.

The training will focus on the target group of AFS volunteers who want to

become multipliers – trainers – themselves. Its aim is to educate new trainers who would be active within the youth field and promote diverse topics through the methods of intercultural learning. There will be one main trainer, Sarah Rathbauer from Austria, and three assisting trainers – Balázs Lato from Hungary, Karoline Kehrer from Austria, and Kristýna Žáková from the Czech Republic.

The participants will come from the countries involved in the PoT cooperation -Czech Republic, Austria and Hungary, as well as from Slovakia and Russia. Hopefully they will all gain lots of new skills and experience and use them within their AFS organisations and the established developing international cooperation the in future.

CONSULTATIVE MEETING ON THE FUTURE OF THE EUROPEAN YOUTH FOUNDATION





European Youth Foundation (EYF) of the Council of Europe is one of the most important sources of support for youth activities European level and an important ally for EFIL. The EYF provides funding for youth meetings (for example: EFIL Volunteer Summer Summit, both in 2008 and 2009), for other youth activities (such as the production of the EFIL short intercultural movies "Snapshots") and for the functioning European secretariats through administrative grants. Although the Foundation disposes of much more limited resources than the European Union, its flexible and co-operative approach makes the EYF a crucial and unique partner for the youth sector.

On April 16-17, the Secretariat of the EYF organised an evaluation meeting in Strasbourg with representatives of youth organisations which benefit from the fund, focused on defining its future evolution. Izabela Jurczik, EFIL's Training Co-ordinator attended the meeting to contribute with the AFS/EFIL perspective and recommendations.

The main outcomes of the meeting included range of practical suggestions to improve the userfriendliness and transparency of the fund, but most importantly pointed at increasing co-operation and synergies of the EYF with other bodies and sectors, both within the Council of Europe and outside. Moreover, issues close to AFS and EFIL work were mentioned among future priorities of the Foundation: intercultural and intergenerational dialogue, operation with countries outside Europe, increasing interactions between formal and non-formal educators.

The strong message from the meeting participants and the EYF Secretariat itself is that all of us should join forces to increase the visibility of the fund and to convince our national governments that it is a worthwhile investment which needs to increase in the future.

2^{ND} BRUSSELS DEBATE EYCI CREATIVITY IN THE CLASS ROOM



The European Policy Council and the European Commission (EC) jointly organised the 2nd Brussels Debate on the topic

"Beyond chalk and talk: creativity in the classroom" on 30 March 2009, within the framework of the European Year of Creativity and Innovation.

EFIL attended the debate, which voiced the opinion of different keynote speakers on the future role of creative and innovative thinking in our increasingly "knowledge-based" society.

Ms. Odile Quintin, Director-General for Education and Culture at the EC, emphasized the need to better equip young

people with the knowledge and competences which will allow them to deal with the current crisis in Europe. Investing in non-formal learning through active "involvement in volunteering" was pointed out as a way to acquire those required skills.

Mr. Eduardo Marçal Grilo, Gulbenkian Foundation, Portugal, stressed the importance of developing a culture of excellence in the education field where schools are given greater autonomy and learning is regarded as a lifelong process that is not strictly limited to schools.

Mr. Lluis Martinez-Ribes, ESADE Business School, Barcelona, pointed out that students should interact with each other and become the "protagonists of the learning experience".

Mr. Dirk Van Damme, Head of the Centre for Education Research and Innovation at the OECD, said that schools should encourage the harmonious development of the individual rather than rely solely on outcomes and leave out creativity and innovation.
