## **ABOUT EFIL**

EFIL, the European Federation for Intercultural Learning, is the umbrella organisation of all AFS organisations in Europe. EFIL's members are European, volunteer-based associations which organise long and short term intercultural stays for young people in a worldwide network.

EFIL is a competent partner in Europe in the educational field, with substantial expertise and experience in intercultural learning. EFIL actively supports its member organisations to implement the AFS mission and strategic plan, and to operate within the European environment.

EFIL's activities revolve around three pillars: Advocacy and Research; Intercultural Learning; and Active Citizenship.

2022 has been declared the European Year of Youth (EYY). - Relevant postgraduate academic background in areas that match the requirements of the job, or alternatively 3 years of professional experience;
- Competences in non formal education and training;
- Proven track record in training and facilitation in the education field, experience on the topics of intercultural learning and inclusion is a plus;
- Previous experience in youth work will be considered an asset;
- Accurate and independent worker;
- A committed and flexible team-player;
- Working level knowledge of English;
- Knowledge of Dutch, French, German or Spanish will also be an advantage;
- Knowledge of project management software will be an asset;
- Availability to travel occasionally abroad;
- Flexibility in occasional work over the weekends and in the evenings;
- Applicants must be a national of an EU Member State, or be entitled to work in the EU.

Prior professional experience is <u>not</u> required.
